

**HB - Half board** includes buffet breakfast and dinner. Drinks are NOT included in meals. – this refers to 4\* hotels.

**FB - Full board** includes buffet breakfast and dinner and served or buffet lunch. Drinks are NOT included in meals.

Prices are per person and per day, applicable for the period from April 5, 2026, to April 13, 2026. (check out on April 13)

Above quoted rates include VAT and tourist tax.

The offer for the 4\* hotel refers to a “no name” 4\* hotel. The exact name of the hotel will be provided no later than 7 days before the group’s arrival at the hotel.

Accommodation will be in „run of the house“ rooms.

### **PRICE CORRECTION**

In order to maintain the proportional value of mutually agreed performances, considering the current circumstances (primarily, the path of inflation rates) which might significantly disrupt such proportions, the contracting parties have agreed that the final nominal price of the contracted service may be corrected provided that after the execution of the contract the cumulative index of monthly inflation rate, published by EUROSTAT for the Republic of Croatia, in the current month exceeds the level of 110.00 compared to March 2025.

The price correction shall be made considering the circumstances of specific case and in line with the principle of equal value of contractual obligations. The price correction referred to in this article can be carried out no later than one month prior to the date of the guest’s arrival, about which the partner shall be notified by e-mail or in another suitable manner. The partner shall inform ORGANIZER within 15 days whether he accepts the new calculation for the price of services or rejects such calculation whereby this Agreement shall be considered terminated. In the latter case obligations of ORGANIZER shall be limited to refund of possibly received amount of the price of services.

### **PAYMENT:**

According to our pro forma invoice:

- As a final confirmation of the booking, it is necessary to pay the deposit in the amount of 20% of the total contracted capacity, at latest 3 days after the group confirmation, otherwise

ORGANIZER will consider that booking is cancelled.

- The rest of the amount is to be made at latest until March 1, 2026.

Payment is considered completed when the funds are received in the organizer's account. All bank fees that arise from payment of invoices or deposits will be settled by the payer.

The paid amount is considered to be the amount that has been credited to the recipient's account by the bank in Croatia.

## **CHILDREN DISCOUNTS AND OTHER DISCOUNTS**

(applicable for the Accompaniment):

Child 0-9,99 years of age in a dbl room with two adults: 100% discount\*

Third person over 10 years of age in a dbl room with two adults: full price

\* The accommodation rate for children is included in the accommodation rate for adults

## **CANCELLATION CONDITIONS**

In case of cancellation, the ORGANIZER will charge the guest a cancellation fee according to the following terms:

- 60 days prior to the arrival: the organizer will not charge the guest
- 59 - 40 prior to the arrival: 20% of the total amount will be charged
- 39 - 30 prior to the arrival: 30% of the total amount will be charged
- 29 - 21 prior to the arrival: 40% of the total amount will be charged
- 20 - 14 prior to the arrival: 60% of the total amount will be charged
- 13 - 7 prior to the arrival: 80% of the total amount will be charged
- 6 and less days prior to the arrival: 90% of the total amount will be charged

In case of a NO SHOW: 100% of the total amount will be charged

Cancellation of individual rooms within a group:

- 10 or more days prior to arrival: up to 10 % of cancelled contracted capacity will not be charged. Capacity exceeding this amount will be charged in full.
- 9 - 4 days prior to arrival: up to 5 % of cancelled contracted capacity will not be charged. Capacity exceeding this amount will be charged in full.
- 3 and less days prior to arrival: All cancelled rooms will be charged in full.

In case of NO SHOW (group or individual) ORGANIZER shall be entitled to claim full compensation for services ordered.

**DEPOSIT:**

Each team is required, before entering the rooms, to leave a deposit / authorize a credit card at the hotel reception in the amount of €500,00 per team as a guarantee against possible damages. A room inspection must be carried out with an authorised hotel representative, and any observed deficiencies must be reported to the hotel without delay.
